


the record, it should also include the pre-filed testimony from Case No. WO-2018-0373 that forms the basis for the cross-examination included in the transcript.

4. Accordingly, for the reasons stated above, MAWC requests that the Commission deny the OPC request to include the Case No. WO-2018-0373 transcript in the record or, in the alternative, asks that in addition to the WO-2018-0373 transcript, the pre-filed Direct Testimony also be included in the record.

WHEREFORE, MAWC submits this *Response to OPC Request* for the Commission's consideration.
