## ORDER DIRECTING NOTICE, SETTING INTERVENTION DEADLINE, DIRECTING FILING, AND SUSPENDING TARIFF

On June 28, 2021, Missouri-American Water Company (MAWC) filed a Petition to Establish an Infrastructure System Replacement Surcharge (ISRS) applicable to its St. Louis County, Missouri, area; and a Motion for Approval of Customer Notice. The Commission must act on the application within 120 days of the application's being filed; therefore, the Commission must issue its order no later than October 26, 2021.

The Commission will give notice of this application to the general public and interested persons and set a date for intervention. In addition, the Commission's Public Policy and Outreach Department will be directed to notify the media and General Assembly members in MAWC's St. Louis County service area. The Commission will also establish a 60-day deadline, pursuant Section 393.1006.1(2), RSMo, for Staff to file a recommendation regarding the application.

MAWC also filed a related tariff sheet, bearing an effective date of July 28, 2021. Because the Staff Recommendation will not be filed before the tariff's effective date, the Commission will suspend the tariff.

## THE COMMISSION ORDERS THAT:

1. The Commission's Data Center shall serve notice by providing a copy of this notice to the St. Louis County Council. The Data Center shall also provide a copy of this notice to the parties in MAWC's last general rate case, File No. WR-2020-0344.

- 2. The Commission's Public Policy and Outreach Department shall make notice of this order available to the media serving MAWC's St. Louis County service area, and to the members of the General Assembly representing MAWC'S St. Louis County service area
- 3. Any entity wishing to intervene in this matter shall file an application to do so no later than July 21, 2021.
- 4. No later than August 27, 2021, the Staff of the Missouri Public Service Commission shall file its recommendation in this matter.
- 5. The following tariff sheet filed by Missouri-American Water Company and assigned Tariff File No. JW-2021-0261, is suspended until October 26, 2021, or until otherwise ordered by the Commission:
