ORDER APPROVING TARIFFS

Issue Date: August 2, 2022

Effective Date: August 11, 2022

On July 21, 2022, the Commission approved the Notice of Agreement. On July 22, 2022, Missouri-American Water Company (MAWC) filed tariffs intended to comply with the Commissions' order.

The tariffs bear an effective date of August 21, 2022. However, MAWC filed a Motion for Expedited Treatment, asking the Commission to approve the tariffs to take effect no later than August 11, 2022. The Commission's Staff filed a Recommendation on July 27, stating that the Commission should approve the tariffs on the expedited basis MAWC requests.

Section 393.140(11) allows the Commission to approve a tariff on less than thirty days' notice upon good cause. Based on MAWC's assertion that it needs timely rate relief, the recommendation of its Staff, and the lack of objection from any party, the Commission finds good cause, and will approve the tariffs on an expedited basis.

THE COMMISSION ORDERS THAT:

1. The Motion for Expedited Treatment is granted.
2. The tariff sheets filed by Missouri-American Water Company on July 21, 2022, and assigned Tariff No. YW-2022-0019 and YS-2022-0020, are approved to become effective on August 11, 2022.

3. This order shall be effective on August 11, 2022.
4. This file shall be closed on August 12, 2022.
