**SECOND MOTION FOR EXTENSION**

**COMES NOW** Missouri-American Water Company (MAWC) and, for its *Second Motion for Extension*, states as follows to the Missouri Public Service Commission (Commission):

1. On September 1, 2021, MAWC filed its Application for certain financing authority pursuant to §§393.190 and 393.200 RSMo. and Commission Rules 20 CSR 4240-2.060, 20 CSR 4240-2.080, and 20 CSR 4240-10.125.


2. On October 28, 2021, Staff filed its recommendation in this case. On November 5, 2021, MAWC filed its *Motion for Extension* asking for an additional two weeks, until November 22, 2021, to respond to the *Staff Recommendation*. The Commission granted that extension by its Order issued November 8, 2021.

3. MAWC and Staff have discussed the matters referenced above. However, MAWC believes that an additional two days would provide an opportunity for a resolution to these matters. Accordingly, MAWC requests a further extension of two days, until November 24, 2021, to respond to the *Staff Recommendation*.

4. Counsel for Staff has indicated that he has no objection to this extension.

**WHEREFORE**, MAWC requests a Commission order granting this *Second Motion for Extension* and providing MAWC until November 24, 2021, to file its response to the *Staff Recommendation*.
