COMES NOW UtiliCorp United Inc. ("UtiliCorp"), Applicant in the captioned matter, and states to the Commission as follows:

- 1. On October 2, 1999, UtiliCorp filed an Application requesting authority to acquire, indirectly, 47.7% of the capital stock of Horizon Energy Distribution Limited, a New Zealand electric distribution utility. The Application requested that the Commission issue an order approving the Application no later than December 15, 1999.
- 2. On October 28, 1999, the Commission issued an <u>Order Directing Response</u>. In said Order, the Commission directed its Staff to advise the Commission of the earliest date Staff could file a recommendation regarding the Application.
- 3. On or about November 10, 1999, the Commission Staff filed a <u>Response of Staff to Order Directing Response</u> setting forth the date by which Staff anticipated that it would be in a position to file its recommendation.
- 4. Since the filing of Staff's Response, certain developments have occurred with respect to the transaction which is the subject of the Application which have had the consequence of making

it no longer necessary that UtiliCorp obtain an order by year end 1999. As a result of these developments, UtiliCorp hereby withdraws its request for expedited consideration of the Application.

WHEREFORE, for the reasons aforesaid, UtiliCorp hereby withdraws its request for expedited consideration of the Application.
