PRELIMINARY RESPONSE TO APPLICATION

COMES NOW the Staff of the Missouri Public Service Commission, and for its Preliminary Response to the Joint Application, states as follows:

- 1. On June 5, 2006, Frimel Water System, Inc., and Lake Lorraine Property Owners' Association filed a Joint Application with the Missouri Public Service Commission seeking authority to transfer the assets of Frimel Water System, Inc., to Lake Lorraine Property Owners' Association and to cease Frimel's operations.
- 2. On June 8, 2006, the Commission issued its Order Directing Notice and Order Directing Filing wherein, among other things, the Commission directed Staff to file, not later than July 10, "its recommendation or a preliminary response to the application."
- 3. In its Order of June 8, the Commission also set an intervention period of thirty days; the effective intervention deadline is July 10, 2006. As of July 9, no persons had sought intervention.
- 4. Staff has reviewed the Joint Application and has identified some issues that require resolution. Staff is engaged in discussions of those issues with the Joint Applicants. Staff will file its final recommendation in this matter, assuming that there are no intervenors, within 60 days of today's date, unless otherwise directed by the Commission.

WHEREFORE, having provided as ordered its Preliminary Response to the Joint Application, Staff prays that the Commission will direct it to file its Memorandum and Recommendation herein within 60 days of the date of today's date.
