

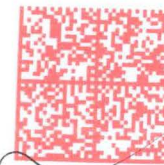

**ORDER DIRECTING NOTICE, SETTING INTERVENTION DEADLINE,
DIRECTING FILING AND SUSPENDING TARIFF**

Effective Date: March 3, 2020

On March 2, 2020, Missouri-American Water Company (MAWC) filed an application requesting that the Commission authorize it to change its Infrastructure System Replacement Surcharge (ISRS), applicable to its St. Louis County service area. The Commission must act on the application within 120 days of the application being filed; therefore, the Commission must issue its order no later than June 30, 2020.

The Commission will give notice of this application to the general public and interested persons and set a date for intervention. In addition, the Commission's Public Policy and Outreach Department will be directed to notify the media and General Assembly members in MAWC's St. Louis County service area. The Commission will also establish a 60-day deadline, pursuant Section 393.1006.1(2), RSMo, for Staff to file a recommendation regarding the application.

In addition, MAWC filed a related tariff sheet, bearing an effective date of April 1, 2020. Because the Staff Recommendation will not arrive before the effective date for the tariff, the Commission will suspend the tariff.

The Commission will also direct MAWC to provide all final and actual supportive documentation for previously estimated ISRS investment to Staff no later than two weeks prior to the due date of Staff's recommendation.

THE COMMISSION ORDERS THAT:

1. The Commission's Data Center shall serve notice by mailing a copy of this notice to the St. Louis County Council. The Data Center shall also mail a copy of this notice to the parties in MAWC's last general rate case, File No. WR-2017-0285.

2. The Commission's Public Policy and Outreach Department shall make notice of this order available to the media serving MAWC's St. Louis County service area, and to the members of the General Assembly representing MAWC'S St. Louis County service area.

3. Any entity wishing to intervene in this matter shall file an application to do so no later than March 30, 2020.

4. No later than April 17, 2020, MAWC shall submit all final and actual supportive documentation for previously estimated ISRS investment to Staff.

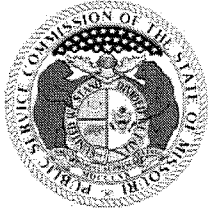
5. No later than May 1, 2020, the Staff of the Missouri Public Service Commission shall file its recommendation in this matter.

6. The following tariff sheet filed by Missouri-American Water Company and assigned Tariff File No. YW-2020-0148, is suspended until June 30, 2020, or until otherwise ordered by the Commission:


