On July 21, 2022, the Commission approved the Notice of Agreement. On July 22, 2022, Missouri-American Water Company (MAWC) filed tariffs intended to comply with the Commissions' order.

The tariffs bear an effective date of August 21, 2022. However, MAWC filed a Motion for Expedited Treatment, asking the Commission to approve the tariffs to take effect no later than August 11, 2022.

The Commission will order its Staff to respond.

THE COMMISSION ORDERS THAT:

1. The Commission's Staff shall file a Recommendation or alternative pleading no later than August 1, 2022.
2. This order shall be effective when issued.
