On December 12, 2022, Missouri-American Water Company (Missouri-American) filed the above-referenced application. The Commission ordered its Staff to file a Recommendation no later than February 28, 2023. Staff later filed a Status Report, in which it stated that it needed until April 14, 2023, to file its Recommendation. The Commission granted Staff’s request.

On April 13, 2023, Staff filed a Motion for Extension of Time. Staff stated that it is still awaiting information from Missouri-American, and that Staff plans to file its Recommendation no later than April 28, 2023. Staff represents that Missouri-American has no objection.

The Commission will grant Staff’s motion.
