# AGREEMENT FOR EXTENSION OF THE "DAY-150" AGREEMENT DEADLINE FOR SMALL COMPANY RATE INCREASE REQUEST

#### **Background**

Moore Bend Water Company (Company) initiated the small company rate increase request for water service (Request) that is the subject of the above-referenced Missouri Public Service Commission (Commission) tracking file by submitting a letter to the Secretary of the Commission under the provisions of Commission Rule 4 CSR 240-3.635, Water Utility Small Company Rate Increase Procedure. The date that the Company's letter was received at the Commission's offices was May 25, 2006<sup>1</sup>. Under the provisions of the above-referenced rule, an agreement regarding the disposition of the Company's Request was to be reached and tariff revisions consistent with that agreement were to be filed on or before October 23.

## **Reason for Extension**

During the course of the Staff's audit of the Company's books and records and before the Staff's audit was completed, and near the date by which an agreement regarding the disposition of the Company's Request was reached and the requisite tariff revisions were to be filed, the stock of the Company was purchased by Mr. Dunn. Additional time was required for Mr. Dunn to review the audit results and the Unanimous Disposition Agreement.

Based on the above, the Company agrees that the date by which an agreement regarding the disposition of the Company's Request is to be reached and the requisite tariff revisions are to be filed should be extended to November 7.
