The Missouri Public Service Commission is setting some of the local public hearings on the rate increase requests of Missouri-American Water Company ("MAWC") and prescribing the notice for such hearings, and will set the remaining hearings by separate order.

Procedure

The Commission set forth a schedule for the drafting of customer notices by order issued on November 18, 2009. The Commission granted the Office of the Public Counsel's Request for Local Public Hearings by order issued on January 13, 2010, reserving its ruling on a schedule for the local public hearings. Because of delays in determining the local public hearing locations, the Commission set forth language for the notices ("proposed notice") by order issued on January 21, 2010. The Commission allowed the parties until January 29, 2010, to file responses to the proposed notice. On January 29, 2010, the Commission received responses from the City of St. Joseph and MAWC. MAWC also filed a reply to the City of St. Joseph's response on February 5, 2010. On February 8, 2010 City of St. Joseph filed a surreply.

Discussion

MAWC and the City of St. Joseph offer suggestions for the notice as follows.

The Commission proposed notice of proposed general revenue increase as a percentage in the aggregate. The increase proposed in each service territory ("territory") is more useful to customers, according to both MAWC and The City of St. Joseph. The City of St. Joseph offers percentages for customer classes in the St. Joseph territory. MAWC suggests using an overall percentage increase per territory and an average dollar amount for residential customers in each territory. In its surreply the City of St. Joseph agrees to the use of an aggregate figure for the overall general revenue increase proposed. The Commission finds MAWC's suggestion informative, especially for the layperson, so the Commission will adopt MAWC's suggestion.

The heading of the Commission's proposed notice describes the increase sought as "possible." The City of St. Joseph suggests describing it as "proposed" and MAWC does not object. The Commission will adopt that suggestion.

MAWC asked that Commission issue its ruling no later than February 9, 2010, and the Commission is accommodating that request.

The Commission will also schedule the local public hearings as follows.

THE COMMISSION ORDERS THAT:

1. No later than ten days before the first local public hearing, Missouri-American Water Company ("MAWC") shall provide an individual notice to each of its customers.

2. For MAWC's sewer service customers, the notice described in paragraph 1 shall include the following language.

Missouri American Water Company ("MAWC") filed a proposal with the Missouri Public Service Commission ("PSC") that may affect your sewer bill. MAWC proposes to increase its gross annual revenues from all its sewer service territories (excluding sales and other gross receipts taxes) by \$143,595 in the aggregate.

For a **[territory]** residential customer, the proposed increase would be **\$xx.xx** per month, if this rate request is approved in full.

MAWC proposes to increase its gross annual revenues from all its water service territories (excluding sales and other gross receipts taxes) by \$48,558,667 in the aggregate.

For the typical **[territory]** residential customer using **x** gallons per [month] [quarter], the proposed increase would be approximately **\$xx.xx** per [month][quarter], if this rate request is approved in full.

[quarter], and [month] [quarter] shall be as set forth in MAWC's Response to Order

Regarding Customer Notices, Appendix A. To those amounts, MAWC shall add the overall

rate increase percentage for the applicable territory.

4. The Commission will convene public meetings, to include a question-and-answer

session and a local public hearing, as follows.

5. Each meeting in paragraph 4 will begin at **6:00 p.m.** with a question-and-answer session at which the Commission's staff will discuss the rate increases at issue in this action. Each meeting will continue with a public hearing starting at **6:30 p.m.** at which persons interested in this action may testify. A regulatory law judge assigned to this action will conduct each public hearing. Each public hearing will last until **9:30 p.m.** or all persons present have had the opportunity to be heard.

6. The notices described in paragraphs 1, 2 and 3 shall include the information applicable per territory as set forth in paragraph 4 and the information in paragraph 5, and the general revenue increase proposed for all territories in the aggregate.

7. The Data Center of the Missouri Public Service Commission shall serve a copy of this order upon the governing body of each county, or city not within a county, in the water and sewer service areas of Missouri-American Water Company.

8. The Public Information Office of the Missouri Public Service Commission shall make notice of this order available to members of the General Assembly representing the residents in the water and sewer service areas of Missouri-American Water Company.

9. This order shall become effective immediately upon issuance.
