STAFF'S RECOMMENDATION ON TARIFF SHEETS

COMES NOW the Staff of the Missouri Public Service Commission (Staff), by and through the undersigned counsel, and submits to the Missouri Public Service Commission (Commission) the following *Recommendation on Tariff Sheets (Staff Recommendation)* and in support thereof states:

1. On March 7, 2012, the Commission issued an *Order Approving Non-Unanimous Stipulation and Agreement (Order)*.

2. The *Order* includes that Missouri-American Water Company (MAWC) "shall file new tariff sheets consistent with this order."

3. The *Order* also states that Staff "shall file a recommendation regarding approving [MAWC's] compliance tariff no later than two days after the tariff sheets" are filed.

4. On March 15, 2012, MAWC filed compliance tariffs, and filed Substitute Tariff Sheets on March 19, 2012 with the following Tracking Numbers: YS-2011-0682, YS-2011-0683, YS-2011-0684, YS-2011-0685, YS-2011-0686, YS-2012-0075, YS-2012-0456, YS-2012-0457, YS-2012-0458, YS-2012-0459, YS-2012-0460, YW-2011-0673, YW-2011-0674, YW-2011-0675, YW-2011-0676, YW-2011-0677, YW-2011-0678, YW-2011-0679, YW-2011-0680, YW-2011-0681, YW-2012-0074, YW-2012-0452, YW-2012-0453, YW-2012-0454, YW-2012-0455, YW-2012-0461.

5. Staff has reviewed the tariff sheets, as listed in Attachment A, attached and incorporated herein by reference, to this *Staff Recommendation* and asserts that those tariff sheets and substitute tariff sheets should be approved, as they are in compliance with the Commission's *Order*.

6. The Commission has authority to approve the proposed tariff sheets pursuant to Section 393.140(11), RSMo (2000).

7. James M. Russo, Rate and Tariff Examination Supervisor, reviewed the tariff sheets listed in Attachment A and states that to the best of his knowledge, information, and belief, the proposed sheets comply with the Commission's *Order*. See *Affidavit of James M. Russo*, attached and incorporated herein as Attachment B.

WHEREFORE, Staff supports tariff sheets listed in Attachment A to this *Staff Recommendation* and states that the tariff sheets as described above, comply with the Commission's *Order*. Staff respectfully recommends the Commission approve these filings.
