**SUPPLEMENT TO  
MOTION FOR CLARIFICATION**

Aquila, Inc. ("Aquila" or "Company") hereby supplements the "Motion for Clarification" that was filed on May 18, 2007. In that motion, Aquila cited language from paragraph 8 of the "Stipulation and Agreement As To Certain Issues" ("Stipulation"), which the Missouri Public Service Commission ("Commission") approved on April 12, 2007, as support for the Company's contention that the parties to the Stipulation intended that hedging costs be recovered through any fuel adjustment clause that is authorized in this case. As further support for that contention, Aquila requests the that Commission also take note of the following language from paragraph 12 of the Stipulation: "The actual cost of fuel and variable purchased power to serve native load will be included in the calculations under any fuel cost recovery mechanism that might be approved in this rate proceeding. The Signatories agree that Aquila shall record as a fuel cost its hedging costs, including settlement gains and losses, in the calculations under any fuel cost recovery mechanism approved in this case."
