### **Background:**

Staff recommended granting the Application of Spectra Communications Group, LLC d/b/a CenturyTel (Spectra) requesting competitive classification of its residential services (other than exchange access service) in the Aurora exchange in Memorandum dated February 8, 2008.

#### **Substituted Tariff Filing:**

In its application for competitive status on the thirty-day track, Exhibit B of the application contains Spectra's illustrative tariff pages reflecting the residential competitive classification for the Aurora exchange. Spectra's application for residential competitive classification notes that it is not requesting any price changes for the Aurora exchange. However, in reviewing Exhibit B (illustrative tariffs) and Tariff Filing YI-2008-0443, Spectra proposed a rate decrease for residential one-party service in the Aurora exchange from \$8.72 to \$7.61.

Spectra outlines in its Application that: "Spectra acknowledges that all rates currently in effect for these exchanges will remain in effect until such time Spectra files a tariff requesting a price change, either increases or decreases, associated with these exchanges. Furthermore, Spectra will be required to notify its customers of any future price increase.

After review by Spectra, Spectra realized that the explanation in the Application was correct with Spectra not requesting any price change for residential service in the Aurora exchange. Accordingly, on February 13, 2008, Spectra submitted substituted tariff sheet reflecting no rate change for residential services in the Aurora exchange (residential one-party service to remain at current rate of \$8.72).

## **Staff Review of Tariff Filing YI-2008-0443:**

After reviewing substituted tariff filing YI-2008-0443, Staff recommends the Commission approve substituted tariff filing (YI-2008-0443) effective February 24, 2008.
