STAFF RECOMMENDATION REGARDING TARIFF FILING

COMES NOW the Staff of the Missouri Public Service Commission (Staff), by and through counsel, and for its *Staff Recommendation Regarding Tariff Filing* states the following:

- On May 6, 2009, the Missouri Public Service Commission (the Commission) received a Rate Increase Request Letter from Noel Water Company, Inc. (Noel or the Company).
- 2. On September 23, 2009, Staff filed a Notice of Company/Staff Agreement Regarding Disposition of Small Water Company Revenue Increase Request (Disposition Agreement).
- 3. On October 7, 2009, the Commission issued its *Order Approving Company/Staff Agreement, Rejecting Tariffs and Authorizing Tariff Filing*, approving the Company/Staff Agreement and authorizing Noel to file tariffs in compliance with the terms thereof.
- 4. On October 13, 2009, Noel filed revised tariff sheets with an effective date of November 12, 2009. This filing was submitted in Tariff File Number YW-2010-0265.

- 5. The Commission thereafter issued its *Order Directing Staff to*File a Recommendation and Setting Deadline for Responses, ordering Staff to file a recommendation as to the tariff revisions no later than October 16, 2009.
- 6. James M. Russo, Rate and Tariff Examination Supervisor, has examined Noel's revised tariff sheets, P.S.C. MO No. 3, 2nd Revised Sheet No. 5, Canceling 1st Sheet No. 5; P.S.C. MO No. 3, 2nd Revised Sheet No. 6, Canceling 1st Sheet No. 6; P.S.C. MO No. 3, 2nd Revised Sheet No. 7, Canceling 1st Sheet No. 7; P.S.C. MO No. 3, 2nd Revised Sheet No. 8, Canceling 1st Sheet No. 8; P.S.C. MO No. 3, 2nd Revised Sheet No. 9, Canceling 1st Sheet No. 9; and P.S.C. MO No. 3, 2nd Revised Sheet No. 13, Canceling 1st Sheet No. 13 and notes that the tariff revisions reflect the agreed-upon rate increase and should be allowed to take effect no later than November 12, 2009. See *Russo Affidavit*, attached hereto.
- 7. The Commission has the authority to approve the subject proposed tariff revisions in accordance with Sections 393.140 (11) and 393.150 RSMo (2000).

WHEREFORE, Staff recommends the Commission issue an order approving the following proposed revised tariff sheets currently pending in Tariff File No. YW-2010-0265 to be effective no later than November 12, 2009.
