2		I. <u>WITNESS INTRODUCTION</u>
3	Q.	PLEASE STATE YOUR NAME AND BUSINESS ADDRESS.
4	A.	My name is Michi Q. Chao. I am employed by American Water Works
5		Service Company, Inc. ("AWWS"), 727 Craig Road, St. Louis, Missour
6		63141.
7		
8	Q.	WHAT IS YOUR POSITION WITH MISSOURI-AMERICAN WATER
9		COMPANY ("MISSOURI-AMERICAN" OR "MAWC" OR THE
10		"COMPANY")?
11	A.	I am employed by AWWS as a Financial Director and Assistant Treasurer for
12		Missouri American Water Company ("Company" or "MAWC"). The Service
13		Company is a subsidiary of American Water Works Company, Inc. ("American
14		Water") that provides various services to American Water's water and
15		wastewater utility subsidiaries. In this proceeding I am testifying on behalf of
16		MAWC.
17		
18	Q.	PLEASE SUMMARIZE YOUR EDUCATIONAL BACKGROUND.
19	A.	In 1995, I received a Bachelor of Science in Business Administration, with a
20		major in finance from California State University of Los Angeles. I am in the
21		process of earning my Master of Business Administration from Webster

1 University, Missouri with an expected completion date in the first quarter of 2 2013.

3 Q. PLEASE SUMMARIZE YOUR EMPLOYMENT EXPERIENCE.

A.

From 1996 to 1997, I was employed by Arroyo Seco Management Services as the Senior Financial analyst. From 1997 to 1998, I joined Cedar Sinai Medical Center as their Senior Accountant. From 1998 to 2000, I was employed by UCLA Medical Center as the Disbursement Manager. In 2000, I joined Health Net, Inc and held two roles, Financial Consultant and Financial Planning and Reporting Manager in the Corporate Business Planning department. My customers included various functional departments such as Corporate Executives, Corporate Finance and Shared Services, and Operations (East coast and West coast). My responsibilities included Financial Statement Performance packages, Financial and Business presentations, Strategic Planning, and Forecasting, Financial compliance (Sarbanes Oxley 302 certification) and Software implementation, training and reporting development.

In August of 2004, I joined American Water as a Consultant through Resources Global Professionals and was hired on September 20, 2004. Through April of 2009, I was the Financial Planning & Analysis Director, responsible for the Financial Statement Reporting packages and Financial Statement Planning/Forecasting for the former Central Region States (Missouri, Illinois, Indiana, Iowa, Michigan, Ohio and Texas). The Financial

1		Reporting packages adhered to Financial Statement variance thresholds (\$
2		and %) and filing requirements. The integrated financial statement
3		plans/forecasts included normalized historical account trend analysis and
4		inflationary factors.

6		American and Texas-American. My duties for MAWC include all aspects of

9		II. PURPOSE OF TESTIMONY
10	Q.	WHAT IS THE PURPOSE OF YOUR TESTIMONY IN THIS PROCEEDING?
11	A.	The purpose of my testimony is to discuss on behalf of MAWC, the AWWS
12		Support Services.
10	•	WILL YOU DE TESTIEVING IN SUPPORT OF ANY SCHEDULES
13	Q.	WILL YOU BE TESTIFYING IN SUPPORT OF ANY SCHEDULES?
14	A.	Yes. I will be testifying to the Service Company support services adjustment
15		on Schedule CAS-14.
16		
17		III. AWWS SUPPORT SERVICES
18	Q.	WHAT ADJUSTMENT WAS MADE TO THE COMPANY'S TEST YEAR
19		LEVEL OF SUPPORT SERVICES?
20	A.	Test year Support Services from the Service Company were adjusted to
21		eliminate one-time costs. In addition, test year costs were adjusted to
22		reflect current ongoing levels of labor and labor related costs including

anticipated labor merit increases and average labor related expense, as well as ongoing levels of Other Service company costs including an anticipated inflationary factor of 1.3%. Lastly, ongoing levels of Service Company costs were adjusted to reflect new cost allocation factors as a result of an increase in the number of customers due to recent acquisitions. Details of this adjustment can be found at Schedule CAS-14, page 12.

9 Q. DOES THIS CONCLUDE YOUR DIRECT TESTIMONY?

10 A. Yes, it does.
