(“Applicant” or “Crexendo”), files this Affidavit, and requests that the Commission supplement its Application for Certificate of Service Authority to Provide Resold and Facilities-Based/UNE Basic Local Telecommunications Services and For Competitive Classification (“Application”) with this Affidavit. In support of its request, Applicant states:

1. On July 9, 2010, Crexendo filed its Application in this case. On August 10, 2010, Staff filed its Report and Recommendation, stating that Crexendo failed to include the required financial documentation for certification to provide basic local telecommunications service, that Crexendo’s Application was therefore incomplete, and that Staff cannot file its recommendation concerning basic local telecommunications service until Crexendo’s application is complete.

2. In response to Staff’s August 10, 2010 Report and Recommendation, Crexendo hereby files the Affidavit of Jon Erickson, stating that Crexendo possess sufficient technical, financial, and managerial resources and abilities to provide basic local telecommunications service.

WHEREFORE, Crexendo Business Solutions, Inc. respectfully requests that the Commission supplement its Application for Certificate of Service Authority to Provide Resold and Facilities-Based/UNE Basic Local Telecommunications Services and For Competitive Classification with this Affidavit.



I, Jon Erickson, being duly sworn, hereby depose and state that:

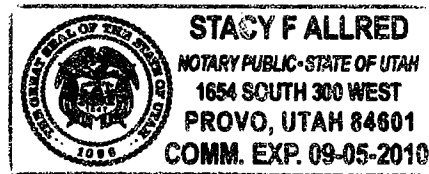
