SUPPLEMENTAL ORDER

By Report and Order issued herein on August 16, 1991, the Commission granted substantially all of the relief requested. That portion of the application concerning the transfer of approximately 63 customers of Arkansas Power & Light Company (APL) in Washington County, Missouri, to Crawford Electric Cooperative, Inc., (Crawford) was held in abeyance until such time as the decision was rendered in a pending application to transfer APL's properties in Missouri to Union Electric Company (UE) in Case No. EM-91-29.

Although the Commission found the agreement concerning the Washington County customers reasonable, the Commission was of the opinion that it would be improper to authorize the conveyance, by UE, of the Washington County properties which the company did not yet own, or the transfer of the customers which UE presently had no authority to serve.

By Report and Order issued and effective October 4, 1991, in Case No. EM-91-29, APL was granted authority to transfer its Missouri properties to UE and to cease doing business in the State of Missouri as a public utility subject to the jurisdiction of this Commission.

In the Commission's opinion it is now proper to grant that portion of the application in this matter concerning the former APL customers in Washington County

for the reasons recited in the Commission's Report and Order of August 16, 1991. The Commission is also of the opinion that the transfer should be accomplished as soon as possible in order to minimize customer inconvenience and confusion by effecting conversion of service from APL to Crawford without any intermediate period of service from UE. This immediate transfer is, of course, contingent upon both joint Applicants securing removal of any mortgage conditions restricting transfer of the properties involved.

IT IS THEREFORE ORDERED:

1. That Joint Applicants Union Electric Company and Crawford Electric Cooperative, Inc., be granted permission to execute that portion of the Territorial Agreement attached to the Amended Application as Exhibit A pertaining to the former Arkansas Power & Light Company customers in Sections 15, 16 and 17 of Township 40 North, Range 2 East, Washington County, Missouri, subject to the conditions herein recited.
2. That Joint Applicants are hereby authorized to perform any and all acts, and execute any and all documents necessary to the execution of the authority herein granted.
3. That the authority herein granted shall be subject to the same conditions as the authority previously granted herein by the Report and Order issued on August 16, 1991.
4. That this Order shall become effective on October 4, 1991.
