

MOTION TO CORRECT AND SUPPLEMENT APPLICATION

COME NOW Access Point, Inc. ("Access Point") and Efficcy Group, Inc. (Efficcy), and for their Motion to Correct and Supplement Application, state as follows:


1. The Joint Application filed herein on March 31, 2000 erroneously included four references to "selected" customers to be transferred from Efficcy Group, Inc. (Efficcy) to Access Point as a result of the proposed transaction. The use of the term "selected" customers was in error, as the transaction contemplates transfer of all of Efficcy's interexchange customers to Access Point. The erroneous references appear in the style of the case, the introductory paragraph, footnote 1, and the final paragraph of the Application. The Application should be corrected to substitute the word "all" for the word "selected" in all instances throughout the Application.

2. Although it was not stated in the Application, Efficcy does not intend to remain in the interexchange telecommunications business in Missouri after transfer of all customers to Access Point. Upon approval of this transaction by the Commission and after transfer of customers to Access Point, Efficcy intends to file an Application to Cancel Certificate and Tariff. Applicants provide this supplemental information as requested by Staff.

3. The consideration for the proposed transaction is an exchange of stock between Access Point and Efficcy. This information was requested by Staff in the course of its review of the Application.

WHEREFORE, Access Point and Efficcy respectfully request that the Commission grant this Motion to Correct and Supplement Application, restyle this case as referenced above, and approve the Application as corrected and supplemented.


