SUPPLEMENT TO DIRECT TESTIMONY OF EMILY HYLAND

COMES NOW Ameren Transmission Company of Illinois (“ATXI”), and files this Supplement to the Direct Testimony of Emily Hyland. In support of this refiling, ATXI states as follows:

1. On April 28, 2021, ATXI filed an Application and Direct Testimony in support of its request for a certificate of convenience and necessity (“CCN”) to construct, install, own, operate, maintain, and otherwise control and manage a 138 kV transmission line and associated facilities in Perry and Cape Girardeau Counties, Missouri (the “Project”).

2. As part of its April 28, 2021 submission, ATXI filed the Direct Testimony of Emily Hyland. Ms. Hyland’s testimony referred to “Schedule EH-02: Summary of Agency Coordination.”
