SUPPLEMENTAL FILING OF TRANSOURCE MISSOURI, LLC, KANSAS CITY POWER & LIGHT COMPANY, AND KCP&L GREATER MISSOURI OPERATIONS COMPANY

Transource Missouri, LLC ("Transource Missouri"), Kansas City Power & Light Company ("KCP&L"), and KCP&L Greater Missouri Operations Company ("GMO") (collectively, "Companies") hereby provide the following information pursuant to the Stipulation and Agreement ("Stipulation") approved by the Commission on August 7, 2013 related to the Iatan-Nashua and Sibley-Nebraska City 345kV transmission projects ("Projects"):

- 1. Attached as Exhibit A is a general description of the Sibley-Nebraska City Project's construction route. This supplements the filing submitted by Transource Missouri and KCP&L Greater Missouri Operations Company on June 27, 2013.
- 2. Pursuant to Paragraph 16 of the Stipulation, Transource Missouri states that the control budget estimate of the Sibley-Nebraska City Project is ** **, with Transource Missouri's share being ** and Omaha Public Power District's share being **. These estimates are currently confidential and have not been publicly announced. Transource Missouri expects Southwest Power Pool, Inc. ("SPP") to disclose this estimate and other transmission project cost estimates in the near future.

- 3. The Sibley-Nebraska City Project's baseline schedule is attached as Exhibit B (which refers to the project as the "Midwest Transmission Project").
- 4. Attached as Exhibit C is the list of the regulated and non-regulated utilities, railroad tracks, and any underground facility which the Sibley-Nebraska City Project will cross. This is provided pursuant to Section 27 of the Stipulation and 4 CSR 240-3.105(1)(D).
- 5. Finally, attached as Exhibit D is the list of the regulated and non-regulated utilities, railroad tracks, and any underground facility which the Iatan-Nashua Project will cross. This is provided pursuant to 4 CSR 240-3.105(1)(D).
- 6. Given the Commission's granting of Transource Missouri's Application for a Certificate of Convenience and Necessity in its Report and Order of August 7, 2013, Transource Missouri does not require any further approvals by any governmental bodies. Nevertheless, the Companies have engaged the counties and municipalities which the Projects will cross to ensure that such governmental bodies are aware of and are given an opportunity to comment upon the Projects' route and construction.
- 7. In accord with Paragraph 6 of the Stipulation, KCP&L and GMO have contributed \$50,000 to the State School Fund by a check made payable to the Director of Revenue which was sent to the Commission on December 13, 2013. Pursuant to instructions from Staff Counsel, the check was mailed to Ms. Helen Davis in the Commission's Budget and Fiscal Services Department.
- 8. The Companies hereby advise the Commission and the parties that the Federal Energy Regulatory Commission ("FERC") issued an order on December 6, 2013 in Docket No. EC13-145-000 that approved the Application submitted by KCP&L and GMO under Section 203 of the Federal Power Act, 16 U.S.C. Section 824b, to transfer from KCP&L and GMO to Transource Missouri certain transmission property in connection with the development of the Projects, including construction work in progress accounts.

9. Finally, the Companies advise the Commission and the parties that FERC issued a letter order on December 17, 2013 in Docket No. ER14-224-000 that accepted the Designee Qualification and Novation Agreement among SPP, KCP&L, GMO and Transource Missouri with an effective date of October 30, 2013. This agreement resulted in the Notifications to Construct ("NTCs") that SPP issued to KCP&L and GMO being novated to Transource Missouri, as contemplated by Paragraphs 24-27 of the Stipulation, and as approved by the Commission in its August 7, 2013 Report and Order (including Paragraph 3 of its Appendix 3).

WHEREFORE, Transource Missouri, LLC, Kansas City Power & Light Company, and KCP&L Greater Missouri Operations Company respectfully supplement the record with the foregoing information related to the Projects.
