SUPPLEMENTAL RESPONSE TO STAFF RECOMMENDATION

COMES NOW Laclede Gas Company ("Laclede Gas"), and files this Supplemental Response to Staff's Recommendation, stating as follows:

- 1. On April 17, 2015, Laclede Gas filed an ISRS that was essentially a refiling of the ISRS Application it filed on January 30, 2015. Pursuant to an agreement among the parties to expedite this filing, on May 1, 2015, Staff filed its recommendation that the April 17 ISRS Application be approved in the amount requested by Laclede Gas. Therefore, Laclede Gas asked that its April 17 tariff be approved by the Commission.
- 2. However, as the Commission noted in its Order issued earlier today, the Staff Recommendation actually asked the Commission to reject Laclede Gas' tariff sheet and approve the rates set forth in Staff's Appendix B. Upon further review, Laclede Gas has discovered that the rates in Staff's Appendix B match all of the rates in Laclede Gas' April 17 tariff, except for the VF rate which, due to rounding, differs by one penny (Staff's rate is \$2.12, while Laclede Gas' is \$2.11). As Staff points out, the difference caused by ISRS roundings are trued up at a later date.
- 3. Laclede Gas apologizes for this oversight, appreciates the Commission's attention to this detail, and continues to concur in Staff's Recommendation. Accordingly, Laclede Gas will, contemporaneously herewith, file a substitute tariff, a copy of which is attached hereto, that matches Staff's ISRS rates in every respect.

- 4. Laclede Gas has shared the substitute tariff with Staff, and Staff has confirmed that such tariff now reflects the rates set forth on Appendix B to Staff's Recommendation in this case, and that Staff has no objection to such tariff going into effect on May 18.
- 5. In light of the parties agreement to expedite the administration of this refiled ISRS, Laclede further thanks the Commission for its prompt response to Laclede Gas' May 11 filing, and for placing this case on its May 13 Agenda, subject to reply.

WHEREFORE, Laclede Gas Company respectfully requests that the Commission issue its Order approving the substituted ISRS Tariff Sheet No. 12 filed today, effective as of the tariff's effective date of May 18, 2015.
