

## **NOTICE OF PREHEARING CONFERENCE**

On October 7, 1987, the Missouri Public Service Commission authorized Kansas City Power & Light Company (KCPL) to terminate central station steam service in downtown Kansas City, Missouri, as of December 31, 1991. KCPL was also instructed to make a good faith effort to sell its steam system to a willing and capable purchaser.

On June 1, 1989, KCPL signed a Memorandum of Understanding with Trigen Energy Corporation (Trigen), providing for the sale of the steam system to Trigen. Title to the steam system actually will be transferred to Trigen-Kansas City District Energy Corporation (Trigen-Kansas City), a subsidiary of Trigen, which will operate the steam system. The Memorandum of Understanding established September 1, 1989, as the closing date for this sale.

KCPL filed an application with the Commission on July 6, 1989, seeking authority to sell its steam system to Trigen-Kansas City, and confirming the revocation of KCPL's public utility obligation to provide utility steam service as of the closing of this sale. Trigen-Kansas City also filed an application on that date, asking for a certificate of public convenience and necessity to provide utility steam service in downtown Kansas City, Missouri, and for approval of its steam rates, rules and regulations.

By Order dated July 14, 1989, the Commission scheduled a Prehearing Conference on these two applications. The Prehearing Conference will be held on August 11, 1989, at 1 p.m., in the Commission's hearing rooms on the fifth floor of the Truman State Office Building in Jefferson City, Missouri. It is not necessary for you, as a KCPL steam service customer, to file an application to intervene in order to attend this Prehearing Conference; applications to intervene may be orally presented at the Prehearing Conference. Matters which may be discussed at the Prehearing Conference include a method and schedule of proceeding with KCPL's and Trigen-Kansas City's applications.
