ORDER APPROVING RECONCILIATION OF CONTESTED ISSUES AND GRANTING MOTION FOR EXTENSION OF TIME

Section 386.420.4, RSMo (Supp. 2013), requires the Commission to prepare and approve a detailed reconciliation regarding the dollar value and rate or charge impact of the contested issues decided by the Commission in this case. The law requires the Commission to allow the parties an opportunity to provide written input regarding that reconciliation.

On July 14, 2016, the Commission directed the parties to prepare and file the reconciliation by July 28, 2016. On July 28, 2016, the parties filed a motion for an extension of time of one day and subsequently filed the reconciliation on July 29, 2016. Staff represents that all of the parties have reviewed the reconciliation and have no objection.

The Commission finds that the reconciliation submitted by the parties is an accurate representation of the dollar value and rate or charge impact of the issues decided by the Commission. The Commission further finds that the submitted reconciliation satisfies the requirements of Section 386.420.4, RSMo (Supp. 2013). The Commission will approve the reconciliation and grant the motion for an extension of time.

THE COMMISSION ORDERS THAT:

- 1. The motion for an extension of time filed by the parties on July 28, 2016, is granted.
 - 2. The reconciliation filed by the parties on July 29, 2016, is approved.
 - 3. This order shall be effective when issued.
