## ORDER EXTENDING TIMELINE

On July 11, 2016, the Commission's Staff filed a motion stating that it and Rex Deffenderfer Enterprises, Inc. d/b/a RDE Water Company have agreed the Small Utility Rate Case Timeline should be extended to allow Staff an additional 30 days to provide its preliminary report of its investigation and audit to the utility and to the Public Counsel. Commission Rule 4 CSR 240-3.050(9) requires Staff to provide that report within 90 days after a small utility rate case is opened. In this case, that report would be due on July 11. However, Commission Rule 4 CSR 240-3.050(12) permits Staff and the company to agree to up to a two-month extension of that date. Given the agreement of Staff and RDE Water Company to a 30-day extension, the Commission will grant Staff's motion.

### THE COMMISSION ORDERS THAT:

1. Staff's Motion for Extension is granted.

2. The deadline for submission of Staff's preliminary report of its investigation and audit to Rex Deffenderfer Enterprises, Inc. d/b/a RDE Water Company and Public Counsel is extended to August 10, 2016.

3. This order shall be effective when issued.
