**ORDER GRANTING MOTION FOR EXTENSION**

After Terre Du Lac Utilities filed a request to increase its annual water and sewer operating revenues, the Staff of the Missouri Public Service Commission filed a Small Utility Rate Case Timeline. On January 10, Staff filed its *Motion for Extension* requesting an extension of 30 days of relevant filing deadlines in the Small Utility Rate Case Timeline. Staff states that it received necessary information for its review on January 1, and needs additional time to perform its review before the current “Day 90” deadline of January 9 to complete its audit. Staff states that Terre Du Lac Utilities and Staff came to a mutual agreement that an extension was proper. Staff’s motion also indicates that the Office of the Public Counsel is unopposed to the extension request. Commission rule 4 CSR 240-3.050(12) permits an extension of deadlines in a small utility rate case upon agreement of the company and Staff.

Finding the request to be reasonable, the Commission will grant the extension request and accept the updated Small Utility Rate Case Timeline submitted with the *Motion for Extension*.

**THE COMMISSION ORDERS THAT:**

1. Staff's *Motion for Extension* is granted. The updated Small Utility Rate Case Timeline is accepted.
2. This order shall be effective when issued.
