As required by a previous Commission order, Missouri-American Water Company filed a reconciliation on June 29, 2018, regarding the issues decided by the Commission in its Report and Order issued on May 2. The Office of the Public Counsel filed a response to that reconciliation on July 13, contending the proposed reconciliation overstates the amount of interest Missouri-American will be allowed to earn on lead service lines costs.

The Commission will establish a time for the filing of responses to Public Counsel's reply.

1. Any party wishing to file a response to Public Counsel's reply shall do so no later than July 17, 2018.
2. This order shall be effective when issued.
