ORDER DIRECTING FILING OF RECONCILIATIONS AND DIRECTING FORMAT FOR FILINGS

On August 3, 2011, the Commission issued an order captioned as "Order Modifying

Procedural Schedule." In that order the Commission provided Staff with specific

instructions with regard to filing the reconciliation in this matter. Paragraph 7 of that order

states:

The Commission's Staff shall file the reconciliation, which shall make a full, side-by-side comparison of the parties' positions on all revenue issues, including all parties that have positions on revenue requirement. At minimum, this shall include Missouri American Water Company's positions on revenue requirement compared to Staff's and the Office of the Public Counsel's positions. The filing shall reflect each of the parties' total revenue requirement, and each of the parties' positions on individual issues and the difference between each of the parties' positions, separately columned, as modeled by the reconciliation filed in SR-2010-0320 on December 29, 2010. Any questions about proper formatting of the reconciliation shall be directed to the Regulatory Law Judge.

The Commission's Staff made no inquiry regarding the proper formatting of the

reconciliation, and Staff filed the reconciliation on February 9, 2012.

The reconciliation that was filed does not comply with the Commission's instructions.

It does not include Missouri American Water Company's ("MAWC") positions on the line

items identified by Staff that are in dispute. Consequently, the differences identified in the

between the positions of Staff, Public Counsel and the Missouri Industrial Energy Consumers ("MIEC") cannot be compared to MAWC's revenue request. The filing does not provide the Commission the information it requires to fully evaluate these issues.

The Commission will direct the filing of new reconciliations, direct that the filings be joint filings between Staff and MAWC, and establish the format for the filings. Staff and MAWC will be required to file reconciliations to compare MAWC's revenue request to each party's position disputing that request.

The first reconciliation will be a comparison of MAWC's revenue request to Staff's position on each line item. The format will be as follows:

First Column, Identify the general actagent of each issue with out

First Column: Identify the general category of each issue with subcategories of each issue, i.e., in the same manner provided in the current reconciliation.

Second Column: Provide the dollar amount of MAWC's proposed revenue requirement for each line item.

Third Column: Provide the dollar amount of Staff's proposed revenue requirement for each line item.

Fourth Column: Provide the dollar amount difference between MAWC's proposed revenue requirement and Staff's proposed revenue requirement for each line item.

Staff and MAWC will file additional reconciliations, in the format described above, to demonstrate the differences between MAWC's proposed revenue requirement and any other party disputing MAWC's proposed revenue requirement providing the same, side-by-side, line item comparison. At minimum, reconciliations shall be filed to demonstrate the

differences in the positions between MAWC, Public Counsel, MIEC and BJC Healthcare.

Any questions about proper formatting of the reconciliations shall be directed to the

Regulatory Law Judge without delay.

THE COMMISSION ORDERS THAT:

1. The Staff of the Missouri Public Service and Missouri American Water Company shall jointly file the reconciliations described in the body of this order, in the proper format, no later than February 15, 2012.

2. This order shall become effective immediately upon issuance.
