STAFF RECOMMENDATION FOR APPROVAL OF TARIFFS

COMES NOW the Staff of the Missouri Public Service Commission ("Staff"), by and through counsel, and recommends that the Missouri Public Service Commission ("the Commission") approve tariff PSC MO No. 2 submitted in Case No. WR-2012-0031 and bearing Tariff Tracking No. YW-2012-0303. In support of this recommendation, Staff states:

- 1. On July 26, 2011, the Commission received a Rate Increase Request Letter from Midland Water Company ("Midland" or "Company") asking the Commission to allow an increase of its annual operating revenues pursuant to Commission Rule 4 CSR 240-3.050.
- 2. On December 28, 2011, Midland filed tariff PSC MO No. 2 in Tracking No. YW-2012-0303 in compliance with the terms of the *Unanimous Agreement Regarding Disposition of Small Water Company Revenue Increase Request ("the Unanimous Agreement")*.
- 3. The Commission has the authority to approve the proposed tariff PSC MO No. 2 pursuant to Section 393.140(11), RSMo (2000).
- 4. James M. Russo, Rate and Tariff Examination Supervisor in the Water & Sewer Department of the Missouri Public Service Commission, participated in the review of tariff PSC MO No. 2 filed in Tracking No. YW-2012-0303, and states that to the best of his knowledge, information and belief, the tariff as set forth in paragraph 2 is true and correct and complies with the terms of *the Unanimous Agreement* filed in this case. See *Affidavit of James M. Russo*, attached here as Appendix A and incorporated by reference.

WHEREFORE, Staff recommends that the Commission issue an order approving the *Unanimous Agreement* filed in Case No. WR-2012-0031 and tariff PSC MO No. 2 pending in Tariff Tracking No. YW-2012-0303, to become effective January 27, 2012.
