## **STAFF'S RECOMMENDATION TO APPROVE TARIFF SHEETS**

1. On April 30, 2014, the Commission issued its *Report and Order*.
2. On May 5, 2014, Lake Region Water & Sewer Company (Lake Region) filed compliance tariff sheets pursuant to that Order.
3. The sewer tariff sheets have been assigned Tariff Tracking No. YS-2014-0448 and bear an effective date of June 4, 2014.
4. The water tariff sheets have been assigned Tariff Tracking No. YW-2014-0447 and bear an effective date of June 4, 2014.




