STATUS REPORT

COMES NOW the Staff of the Missouri Public Service Commission, by and through counsel, and for its *Status Report* respectfully states as follows:

1. On April 15, 2016, Respondents filed a status report indicating they were in the process of organizing and finalizing a sale and requesting an additional 60 days to update the Commission on the progress of the sale.

2. On April 18, 2016, the Commission ordered parties to file another status report by July 15, 2016.

3. Staff has received little contact from Respondents since the last status report, but Staff counsel learned from Respondents' counsel that the sale is not yet final, as the buyer and seller are still working out agreeable terms. Staff understands that Respondents intend to request additional time to complete the sale.

4. Staff would not object to an extension of time for Respondents to complete the sale and transfer of assets, but Staff notes that the above captioned cases have been open for over a year and need to be resolved. Accordingly, Staff respectfully requests the Commission to order Respondents to file within 60 days either a finalized asset purchase agreement, or a procedural schedule with which Respondents believe they are able to comply.

5. On July 14, 2016, Staff contacted Mr. Hernandez, the attorney for Respondents, and provided this pleading for comment. As of the time of this filing, Staff has not received any comments from Respondents.

WHEREFORE, Staff submits its *Status Report*, and respectfully requests the Commission order Respondents file within 60 days either a finalized asset purchase agreement, or a procedural schedule with which Respondents believe they are able to comply.
