

Issue Date: September 29, 2016 Effective Date: September 29, 2016 On July 27, 2016, the Commission issued an Order Directing Respondents to File an Answer after this case had been pending for some time. However, rather than filing an answer, the Respondents' attorney filed a motion to withdraw, noting that he had not had any communications with his clients. The Commission granted that motion. Now the Staff of the Missouri Public Service Commission (Staff) has requested that the Commission allow an additional opportunity for the Respondents to answer the Complaint. - 2. Any answer to this Complaint shall be filed no later than October 31, 2016.
- 3. This order shall be effective when issued.
