# ORDER GRANTING MOTION TO AMEND COMPLAINT AND SETTING DEADLINE FOR FILING MEDIATION STATUS

Issue Date: September 28, 2016 Effective Date: September 28, 2016

On September 6, 2016, the Office of the Public Counsel ("OPC") filed a *Motion to Amend Complaint* seeking to amend the *Complaint* filed on March 31 against Moore Bend Water Utility, LLC ("Moore Bend"). Commission Rule 4 CSR 240-2.080(18) allows a pleading to be amended by leave of the Commission. Under Commission Rule 4 CSR 240-2.075(13), parties were given ten days from the date OPC filed its motion to file an objection, but no objections were received. The Commission will grant OPC's motion and accept the *Complaint-Amended*.

Moore Bend previously requested mediation and the Commission stayed the deadline for the filing of an answer to provide OPC an opportunity to respond to the mediation request. At a discovery conference held on April 20, the parties expressed an interest in attempting to resolve the dispute informally, without the assistance of a mediator. The Commission will now direct OPC to submit a status report stating if the parties are still working on an informal resolution or request the appointment of a

mediator by the Commission. If OPC states it is no longer interested in mediation, the Commission will set a deadline for Moore Bend to file an answer to the Complaint-Amended.

#### THE COMMISSION ORDERS THAT:

- The Office of the Public Counsel's Motion to Amend Complaint is granted.
   The Complaint-Amended is deemed filed with the Commission.
- 2. No later than October 11, 2016, the Office of the Public Counsel shall file a mediation status-report with the Commission, as described in the body of this order.
  - This order shall be effective when issued.
