On September 27, 2018, the Commission directed the Staff of the Missouri Public Service Commission (“Staff”) to file a report concerning the Complaint no later than November 12, 2018. On November 5, 2018, the Staff asked the Commission to extend the deadline for the report to November 16, 2018, because the Staff had not received data requests from Mid-American Water Company, did not anticipate receiving them until November 5, and November 12 is a holiday.
