**ORDER DIRECTING STAFF TO FILE RECOMMENDATION AND  
SETTING DEADLINE FOR COMMENTS**

On June 26, 2013, Roy-L Utilities, Inc. ("Company") submitted a written request to the Commission for an increase in its water and sewer revenues. On May 9, 2014, Staff of the Missouri Public Service Commission filed a *Notice of Unanimous Agreement Regarding Disposition of Small Water & Sewer Company Revenue Increase Request*. Staff indicated in its notice that Staff, Company and the Office of the Public Counsel reached a unanimous agreement that would provide for an increase of \$1,514 for the Company's water operations and \$7,393 for its sewer operations. Staff's notice also indicated that Company would withdraw its previously filed tariff sheets and submit new tariffs, compliant with the agreement, bearing effective dates at least thirty days from the date of filing.

On May 12, 2014, Company filed substitute tariff sheets (Tracking Nos. YW-2014-0401 and YS-2014-0402) with effective dates of May 23, 2014.

The Commission will set a deadline for Staff to file a recommendation on the substitute tariffs filed by Company. The Commission will also set a deadline for other interested entities to file comments about the substitute tariffs.

**THE COMMISSION ORDERS THAT:**

1. The Staff of the Commission shall file a recommendation on the substitute tariff sheets filed by Roy-L Utilities, Inc. no later than May 16, 2014. Staff will specifically address if the tariff sheets are in compliance with the terms of the unanimous agreement between the parties.
2. Interested parties may file comments on the substitute tariff sheets filed by Roy-L Utilities, Inc. no later than May 16, 2014.
3. This order shall become effective upon issuance.
