**ORDER SETTING LOCAL PUBLIC HEARINGS**

On September 23, 2015, the Commission issued an order adopting a procedural schedule recommended by the parties. The schedule allows for local public hearings to be held from January 25 through February 12, 2016. On September 28, 2015, the Office of the Public Counsel (Public Counsel) filed recommended locations for the local public hearings, including both specific locations and specific cities. With the exception of some of the specific locations within the suggested cities, the Commission will set the hearings according to Public Counsel's suggestions.

**THE COMMISSION ORDERS THAT:**

1. The Commission's Public Information Office shall make an informal presentation and conduct a question-and-answer session for the public at the beginning of each local public hearing.

2. Missouri-American Water Company, the Staff of the Commission and the Office of the Public Counsel shall make a representative available to address substantive issues during the question-and-answer session. Any other party may also do so.

3. No later than 10 days before the local public hearings, Missouri-American Water Company shall provide notice of the hearings to each of its customers.

4. The Commission's Public Information Office shall make notice of this order available to the members of the General Assembly representing, and the news media serving, Missouri-American Water Company's service area.
