ORDER DIRECTING RESPONSE REGARDING TARIFF EFFECTIVE DATE

On June 12, 2017, Staff, Public Counsel, and Ridge Creek Water Company, LLC, submitted a Total Disposition Agreement that will resolve Ridge Creek Water's request for a rate increase. On June 21, Ridge Creek Water submitted a tariff revision to implement the new rates resulting from the Total Disposition Agreement.

In reviewing these matters, the Commission notes that the Total Disposition Agreement (paragraph (7)) indicates the implementing tariff is to bear an effective date of August 1, 2017. The implementing tariff filed by Ridge Creek Water bears an effective date of July 21, 2017. The difference in effective date of the tariff means that if the proposed tariff is approved, the rate increase will go into effect ten days sooner than contemplated in the Total Disposition Agreement. The Commission will direct the parties to state their position regarding this difference.

THE COMMISSION ORDERS THAT:

1. No later than June 27, 2017, the Staff of the Commission, the Office of the Public Counsel, and Ridge Creek Water Company, LLC, shall file a pleading, or pleadings, indicating whether the compliance tariff filed by Ridge Creek Water Company, LLC, should be approved with its proposed July 21, 2017 effective date.

2. This order shall be effective when issued.
