The Missouri Public Service Commission is setting local public hearings, in consideration of the *Joint Local Public Hearing Setting Suggestions*¹ filed by Staff on behalf of all parties.

THE COMMISSION ORDERS THAT:

- 1. <u>Schedule</u>. The Commission will convene a local public hearing on the rate increase request at 6:00 pm on Wednesday, October 18, 2017 at the Knights of Columbus Council 8920, 7057 Old 66, Cuba, MO 65453.
- 2. <u>Statements.</u> At the local public hearing, Indian Hills Utility Operating Company, Inc. ("applicant"), Staff, and the Office of the Public Counsel shall each set forth its perspective on the action by making available:
 - a. A written statement, not more than one page, with sufficient copies for the attendees; and
 - b. At least one representative in person to address substantive issues and respond to questions from the attendees.
- 3. <u>Question-and-Answer Session</u>. Each local public hearing will begin with a question-and-answer session. At each question-and-answer session, the Commission's

staff ("Staff") will make a presentation on the rate increases at issue in this action. Staff and representatives of other parties to this case will answer questions about the rate increases at issue in this action. The question-and-answer session will last not more than 30 minutes.

- 4. Public Testimony. At the close of the question-and-answer session, a regulatory law judge shall take public testimony.
- 5. Notice. The applicant shall provide an individual notice to each of its customers no later than ten days before the local public hearing.
 - a. The Commission's Data Center shall serve a copy of this order on the governing body of each county in the applicant's service areas.
 - b. The Commission's Public Information Office shall make this notice and order available to members of the General Assembly representing the residents of the applicant's service areas.
 - 6. Effective Date. This order is effective when issued.
