## ORDER DIRECTING FILING OF ADDITIONAL EXHIBITS AND REVISING DEADLINE FOR INITIAL BRIEFS

Near the conclusion of the March 8, 2018 evidentiary hearing, the regulatory law judge stated that the record would remain open to allow Missouri-American Water Company (MAWC) to submit additional exhibits sought by the Commission. The Commission requested MAWC submit an exhibit identifying the percentage of residential customers in the "Rate A" class. In addition, the Commission asked MAWC to provide rate comparison schedules for all rate classes (similar to Exhibit 136) with an \$8.00 or \$9.00 charge applied for customers with 5/8" meters.<sup>1</sup>

The Commission will set a deadline for MAWC to submit these exhibits and a deadline for other parties to file objections to the admission of the exhibits into the record. The Commission will also modify the procedural schedule by changing the deadline for the filing of initial briefs.

## THE COMMISSION ORDERS THAT:

1. No later than March 23, 2018, Missouri-American Water Company shall submit marked exhibits of the information identified in the body of this order.
