**ORDER MODIFYING DEADLINE TO FILE STATEMENT OF POSITIONS**

In the Order Scheduling Evidentiary Hearing and Setting Procedural Schedule, the Commission set a February 20, 2018 deadline for the parties to file their separate statement of positions. On February 16, 2018, Missouri-American Water Company (MAWC) filed a motion requesting the deadline be extended until February 21, 2018. While the Commission will not grant MAWC's motion, many of the parties agreed to an alternative option proposed by the presiding judge. No party opposed the suggestion.


The Commission will therefore modify the deadline for the parties to submit their statement of positions.

**THE COMMISSION ORDERS THAT:**

1. No later than 1:00 p.m. on February 20, 2018, parties shall file their statement of positions on those issues that will be presented to the Commission during the first two days of the evidentiary hearing. Failure by a party to submit a statement on those issues will be considered by the Commission as a statement of no position on those issues. Parties shall file their statement of positions on all remaining issues no later than February 21, 2018.

2. This order shall be effective when issued.
