On October 9, 2018, the Staff of the Missouri Public Service Commission (Staff), Middlefork Water Company (Middlefork), and the Office of the Public Counsel filed a unanimous disposition agreement to fully resolve Middlefork's revenue increase request. On October 17, 2018, Middlefork filed tariffs to comply with the agreement. The Commission will direct Staff to file a recommendation regarding the tariff sheets.

### THE COMMISSION ORDERS THAT:

1. No later than October 29, 2018, the Staff of the Missouri Public Service Commission shall file a recommendation regarding the tariffs filed on October 17, 2018.
2. This order shall be effective when issued.


