The Commission is consolidating these files because they address a single complaint.

On August 4, 2016, the complainants filed the *Complaint*. Based on the *Complaint's* charges related to water service, the Commission assigned the *Complaint* File No. WC-2017-0037.<sup>1</sup> Under that file number, the Commission issued its *Notice of Contested Case and Order Directing Filing*, requiring service by certified mail, an answer from respondents, and a report from Staff.<sup>2</sup>

Based on the *Complaint's* charges related to sewer service, the Commission also assigned the *Complaint* File No. SC-2017-0039. Under that file number, the Commission will not separately require service by certified mail, an answer from respondents, and a
