On October 17, 2017, Highway H Utilities, Inc. ("Highway H") filed a *Motion to Stay Proceedings* requesting the Commission stay any action resulting from the Commission's September 19, 2017 *Order Granting Motion for Default Determination*. Highway H states that it filed applications with the Commission requesting authority to sell its water and wastewater systems to the City of Waynesville and to Pulaski County Sewer District Number 1. If the applications are approved, Highway H states that it will cease providing water and sewer service and will no longer be a Commission-regulated public utility.

Should any entity oppose Highway H's *Motion to Stay Proceedings,* the Commission will set a deadline for the filing of responses.
