ORDER GRANTING MOTIONS TO CONVENE LOCAL PUBLIC HEARING, COMBINE NOTICES, AND WAIVE TIME LIMIT

The Missouri Public Service Commission is granting the motions of the Office of

Public Counsel ("OPC") to:

- Convene a local public hearing ("motion to convene local public hearing").
- Combine notice of local public hearing with the notice of the proposed tariffs ("motion to combine notices").
- Waive the time limit for notice of the proposed tariffs ("motion to waive time limit").

The Commission reserves ruling as to:

- The local public hearing's setting, and
- OPC's motion to suspend tariffs ("motion for suspension").

The Commission will issue those rulings by separate order.

Each of the motions is part of The Office of Public Counsel's Request for Local

Public Hearing ("request"), ¹ filed in response to tariff sheets filed in each of these actions.

The request alleges, in support of each motion, environmental issues, differences over revenue requirement, and cost savings from combined notices. As to the motions granted

in this order, the Commission will dispense with the time for responses,² because the notice of proposed tariffs is due to issue two working days from the date of this order.³ That impending deadline does not so directly affect the rulings reserved in this order. Nevertheless, the Commission intends to rule on those motions expeditiously.

Therefore, the Commission will reserve ruling on the setting of the local public hearing and the motion for suspension; and will grant the motions to convene a local public hearing, combine notices, and waive time limit.

THE COMMISSION ORDERS THAT:

1. The motion to convene a local public hearing, as described in the body of this order, is granted.

2. The motion to combine notices, as described in the body of this order, is granted.

3. The motion to waive time limit, as described in the body of this order, is granted.

4. This order shall become effective immediately upon issuance.
