ORDER SETTING TIME TO RESPOND

The procedural schedule¹ is the subject of motions filed by Office of Public Counsel ("OPC") ² and Hickory Hills Water & Sewer Company ("Hickory Hills"): ³

- OPC states that counsel has a scheduling conflict and proposes an alternative schedule.
- Hickory Hills states that the receiver is out of the country for two weeks, and seeks a new schedule, but does not propose an alternative schedule.

The Commission is setting the time to respond to Hickory Hills' motion, making its own proposal, and setting the time for responses to that proposal.⁴

The current procedural schedule, party conflicts, and party proposals are as follows.
