ORDER SETTING DEADLINE FOR OBJECTIONS AND STAFF RECOMMENDATION ON COMPLIANCE TARIFFS

On July 26, 2017, the Commission issued an order approving a stipulation and agreement and directing Terre Du Lac Utilities to submit revised tariff sheets in compliance with that order. On August 30, 2017, Terre Du Lac Utilities filed revised tariff sheets that were assigned tracking numbers YS-2018-0024 and YW-2018-0025.

The Commission will set a deadline for the Commission's Staff to file a report indicating whether the tariff sheets are in compliance with the Commission's July 26, 2017 order. The Commission will also set a deadline for the filing of objections asserting that Terre Du Lac Utilities' tariff sheets are not in compliance with the Commission's order.

THE COMMISSION ORDERS THAT:

1. No later than September 8, 2017, the Commission's Staff shall file a report on the compliance of Terre Du Lac Utilities' tariff sheets (Tracking Nos: YS-2018-0024 and YW-2018-0025) with the Commission's July 26, 2017 Order Approving Disposition Agreements and Small Company Rate Increase.

- 2. No later than September 11, 2017, objections to the compliance of Terre Du Lac Utilities' tariff sheets (Tracking Nos: YS-2018-0024 and YW-2018-0025) with the Commission's July 26, 2017 Order Approving Disposition Agreements and Small Company Rate Increase may be filed.
 - 3. This order shall be effective when issued.
