**ORDER SCHEDULING EVIDENTIARY HEARING AND
SETTING PROCEDURAL SCHEDULE**

On October 11, 2016, Terre Du Lac Utilities submitted a letter requesting the Commission approve an increase in the company's annual water and sewer rates. Consistent with the Commission's rule for Small Utility Rate Case Procedure,¹ the Commission's Staff performed an investigation. On May 9, 2017, Staff filed a *Notice of Partial Disposition* on behalf of the parties, including Terre Du Lac Utilities and the Office of the Public Counsel. The notice stated that although an agreement was reached on certain matters, the parties were unable resolve many issues. The parties request an evidentiary hearing be set to address all outstanding matters.

The Commission will therefore schedule an evidentiary hearing and establish a procedural schedule.
