ORDER MODIFYING PROCEDURAL SCHEDULE

On May 18, 2017, the Commission issued an order scheduling an evidentiary hearing and establishing a procedural schedule. The Commission revised the procedural schedule on June 1, 2017. On June 28, 2017, the Staff of the Missouri Public Service Commission, Terre Du Lac Utilities, and the Office of the Public Counsel (jointly, the "Parties") filed a Joint Motion to Suspend Procedural Schedule. The Parties state a potential settlement that will resolve all pending issues is being discussed. The Parties request the Commission suspend the procedural schedule to allow for continued settlement discussions. The Commission will grant the request and suspend the procedural schedule.

THE COMMISSION ORDERS THAT:

1. The procedural schedule modified by the Commission on June 1, 2017, is hereby suspended.
2. No later than July 5, 2017, the Parties shall file a status report with the Commission indicating if an evidentiary hearing is needed.

3. This order shall be effective when issued.
