1. No later than August 2, 2017, Missouri-American Water Company shall file a reply to the *Response to Motion to Establish Future Test Year and Test Year Recommendation* filed on behalf of the Midwest Energy Consumers' Group; the Missouri Industrial Energy Consumers; the Office of the Public Counsel; the City of Joplin; the City of Jefferson City; the City of Warrensburg; the City of St. Joseph; the City of Riverside; and the Consumers Council of Missouri.

2. No later than August 2, 2017, Missouri-American Water Company shall file a reply to the Staff of the Missouri Public Service Commission's *Response to Motion to Establish Future Test Year*.

3. This order shall be effective when issued.
