Issue Date: February 23, 2018 Effective Date: February 23, 2018 In its Order Scheduling Evidentiary Hearing and Setting Procedural Schedule, the Commission set February 26, 2018, as the first day of a two-week evidentiary hearing. On February 23, 2018, the Commission was notified that a settlement in principle was reached on many of the disputed issues. The parties expect to file a partial settlement agreement by Wednesday February 28, 2018, for the Commission's review. On February 23, 2018, Staff also filed an Amended Issues List that identified the items not yet resolved by the parties.

The Commission will therefore modify the hearing schedule by changing the start date for the evidentiary hearing to Friday, March 2, 2018.

## THE COMMISSION ORDERS THAT:

1. The start date for the evidentiary hearing, as previously ordered by the Commission in its September 6, 2017 *Order Scheduling Evidentiary Hearing and Setting Procedural Schedule*, is revised to now begin on Friday, March 2, 2018, at 8:30 a.m. At that time, the Commission shall hear evidence on: 1) Allocation; 2) Coordination with Local Municipalities for Water Main Replacement; and, 3) Cedar City/Jefferson City Airport and Fire Protection.

2. This order shall be effective when issued.
